1. That I am the Secretary of Panskura Vidyasagar Social Welfare Society at Vill. - Kanakpur, PO-Naranda, Purba Medinipur, 721139 (hereinafter referred to as the said 'Society').
2. That the said Society has decided to increase intake by one unit of 'Panskura Primary Teachers' Training Institute (Private) running by the Society and as such a special emergency meeting was held on 04/02/2013 in the Society office at 8 am in presence of (1) Mrs. Alpana Maiti, (2) Asok Maiti, (3) Dr. Mahammad Ali, (4) Dr. Narayan Chandra Mandal and (5) Sri Dibyendu Bikash Maiti.
3. That in the said meeting the agenda was withdrawal of applications bearing IDs: ERCAPP1657, ERCAPP1658 & ERCAPP29 from ERC, NCTE and retention of application ID: ERCAPP1516.
4. That in the said meeting dated 04/02/2013, the President of the said Society, respected Mrs. Alpana Maiti took the chair and started with thanks to all appearing members. 1<sup>st</sup> of all the decision taken in the previous meeting were heard out and the same were approved unanimously and the below mentioned decision was approved unanimously. Four (4) applications (IDs: ERCAPP1516, ERCAPP1657, ERCAPP1658 & ERCAPP29) were made to ERC, NCTE for increase of intake for 4 units in Panskura Primary Teachers' Training Institute (Private) at the wrong conception that the institute has been recognized by NCTE since 2005 and affiliated to WBBPE since 2003 which is more than 7 years. It is learnt from NCTE norms and standard that only one application at a time is acceptable by ERC NCTE. That in the said meeting the decision was withdrawal of applications bearing IDs: ERCAPP1657, ERCAPP1658 & ERCAPP29 from ERC, NCTE and retention of application ID: ERCAPP1516. The meeting is declared ended with thanks to the members by the President by signing the said resolution on 04/02/2013.
