Pursuant to the rules and regulations of WBBPE and ERC-NCTE the following decisions have been taken unanimously at the meeting held on 4^{th} Oct. 2016.

- 4. All the fees and other receipt must be deposited to PPTTI A/C in Bank of Baroda, Panskura Branch.
- 5. The Bank A/C will be operate jointly by President, Secretary & Principal.
- 6. No cash receipt will be allowed from anybody.
- 7. All benefits of employees e.g. E.P.F., ESI, Grade pay & yearly increment @ 3% as per Govt. of West Bengal Rule will effect from 01-04-2016 with retrospective effect as per financial rule.
- 8. All academic activates will perform by Principal. No interference of any member/members or office bearer/bearers of GB will be allowed.
- 9. Salary, employee benefits will be disbursed through ESC within 12th day of next month and all other expenditure will be disbursed exclusively from Bank Account after verifying all relevant documents.
- 10. A office will be constructed for office bearers-members of PPTTI GB and Organizing society at the 5th floor of the college building.
